#### 2. Single Collateral Management Rulebook for Europe (SCoRE) - updates

##### 2.1. SCoRE Triparty Collateral Management Rulebook – 2021 update

In December 2019, the first version of the Single Collateral Management Rulebook for Europe

on Triparty Collateral Management was published. Since then, further work has been conducted on ISO 20022 compliant messages and additional guidance on the implementation of the Standards. The updates have been introduced in the Rulebook (in track changes). A written consultation on the Rulebook is organised with the Triparty Collateral Management Expert Group until 9 April 2021.

## **2.2. SCoRE Corporate Actions Rulebook – 2021 update**

The first version of Single Collateral Management Rulebook for Europe on Corporate Actions (CA) was published in December 2019. Since then, further guidance was developed on business day conventions (CA Standard 6) and payment time (CA Standard 8). Further work has also been conducted on the applicability of the AMI-SeCo Standards on Corporate Actions (for debt instruments) to other instruments. The Rulebook has now been updated to reflect this additional progress together with other updates stemming from additional guidance for implementation provided by the Asset Servicing Expert Group. A written consultation on the Rulebook is to be organised until 16 April 2021.

## **2.3. SCoRE Billing Processes Rulebook – debriefing on the 2021 update**

In December 2019, the first version of the Single Collateral Management Rulebook for Europe on Billing Processes was published. Since then, further updates are being reflected (e.g. addition of Service Categories and editorial changes to align terminology). The ECB will debrief on the updates and the planned consultation.

### 3. **Monitoring implementation – Updated Adaptation Plans and SCoRE Surveys H1/2021**

NSGs were invited to prepare updated Adaptation Plans by the beginning of February 2021,, following the AMI-SeCo's agreement to reschedule the implementation of the SCoRE Standards from November 2022 to November 2023, covering the first wave adoption of the Standards on Triparty Collateral Management, Corporate Actions and Billing Processes. The milestones had also been adapted accordingly [in the SCoRE planning document]. The ECB and NSGs have reviewed the Adaptation Plans. A status update will be provided.

The second SCoRE survey was sent out on March 1 to collect information per Standard from CSDs, TPAs, Custodians, Issuers and Issuer Associations in each market. Questionnaires were issued per entity type (e.g. per CSD, TPA, Custodian etc.). The deadline for submission of completed surveys is Friday 9<sup>th</sup> April.

CMH-TF members are invited to take note of the status of the updated Adaptation Plans. Members are also invited to ask for further clarifications where needed.

The AMI-SeCo underlined the need to maintain the momentum on SCoRE work and also make contributions to establishing a Capital Markets Union in Europe. The CMH-TF has established four Expert Groups, which are contributing to the harmonisation of post trade activities, i.e. on triparty collateral management, bilateral collateral management asset servicing/billing processes and taxation processes
